By integrating Kiteworks with best-in-class security solutions, your organization can create a robust defense against malware, data leaks, and advanced persistent threats.

- **Protect outbound content from leaks with DLP**—Integrate with your ICAP-based enterprise data loss prevention (DLP) service, such as Forcepoint or Digital Guardian, to scan outbound content. Configure automated policies that can alert, log, and/or block transfers based on the DLP results.
- **Protect your enterprise from zero-day threats with ATP**—Integrate with your ICAP-based enterprise advanced threat protection (ATP) service, such as Check Point SandBlast or Trellix. Configure automated policies that can alert, log, and/or quarantine transfers based on the ATP results.
- **Protect against malware in documents with CDR**—Integrate with your ICAP-based enterprise content disarm and reconstruction (CDR) service, such as Forcepoint Zero Trust CDR. Kiteworks sends each inbound document to the CDR, which immediately returns a sanitized, usable version of the document that Kiteworks forwards to the recipient.
